## **Description of the study**

Care concern notifications are a common aspect of foster care for many people involved in the foster care system. In 2019-2020, over 183,000 care concern notifications were made, with nearly 49,000 of the 70,000 direct abuse claims being substantiated following investigation. However, despite this overwhelming number of care concerns, there is little research to date on the lived experiences of carers and foster children who have been involved in a care concern process. This study aims to gain a better understanding of the care concern notification and investigation process, and the impact that involvement in this process has on both foster children and their carers.

This project is led by Professor Damien Riggs (Flinders University) and Kelly Ryan (UniSA). The interviews will be conducted by Shoshana Rosenberg, and all data will be analysed by the research team.

# Purpose of the study

The purpose of this study is to document lived experiences of the care concern process,

including the details of the notifiable incident, subsequent foster care agency actions, and any immediate or longer-term effects that involvement in the process has had on participants. The study also aims to add to the body of knowledge surrounding foster care experiences more broadly, in particular the effect of foster care agency processes on the wellbeing of foster children, as well as the ways the foster care system can better manage care concerns and their emotional, relational, and/or legal ramifications. By gaining better insight into these processes and their impact on involved parties we aim to create best practice guidelines on care concern management which could be used to improve how these processes are carried out by foster care agencies and the foster families they are assigned to work with.

## What will I be asked to do?

You are invited to take part in this study as you are someone who is either a current or previous foster carer who has been involved in a care concern notification. The study will involve an audio-recorded 60-minute interview which will be conducted over Zoom or Microsoft Teams at a time that is convenient for you. Participation in the interview is voluntary and you may withdraw any time before or during the interview. You will also be given a month-long period following the interview to withdraw.

# **Benefits of Study**

Participants are not expected to directly benefit from the study, however each participant will receive a \$25 voucher from Connecting Foster and Kinship Carers South Australia as recognition of their time.

# **Confidentiality and Privacy**

If you choose to participate, your participation will be anonymous to everyone other than yourself, and all information provided will be treated as strictly confidential. Only the investigators listed on this form will have access to the individual information you provide. An external transcription service will transcribe the audio recorded interviews, but will not have access to any personal information about you recorded in the demographic form. Publications arising from this study will protect your anonymity, including by removing any identifying or personal information. The only exception to this anonymity is in the case that information is disclosed which indicates a potential risk of harm to a person, in which case the research team is bound by the state's mandatory reporting laws.

# **Data Storage**

Information collected will be stored securely on a password protected computer at Flinders University and on the Flinders University computer server during and after the study. On project completion, all data will be securely stored on the Flinders University computer server for at least five years after publication of the results. Only members of the research team will have access to the transcribed interview data. Following the required data storage period, all data will be securely destroyed according to university protocols.

## Are there any risks or discomforts if I am involved?

As this study is aimed at gaining an understanding of care concern incidents and subsequent notification processes, there will be topics of discussion which are difficult or potentially

triggering, including questions about experiences of violence, abuse, and/or distress. You are not obligated to divulge any information or discuss any topics which you find difficult, and can request to skip a question at any time during the interview.

The researchers do not expect the interview questions to cause any significant emotional harm or discomfort to the participants. We do, however, ask that you consider whether there is any chance that the study focus might be significantly upsetting for yourself, and if there is any chance that participating may cause excessive or unnecessary distress, to determine whether participation is appropriate for you and your mental wellbeing. If you do choose to participate and subsequently experience feelings of emotional discomfort or distress as a result of participation, the following phone services are available should you wish to speak to someone other than the research team:
